#### Minutes of the Parish Council Meeting held in Carbrooke Village Hall on 12 October 2021

### **1** Public Participation

Objections were raised to the planning application at Summer Lane Kennels.

### 2 Apologies for Absence

Apologies were received from Cllrs Colley, Long, Tinson and Wormall.

### **3 Report from Breckland and Norfolk County Councillors**

Cllr Crane (Breckland Council) noted that the Local Plan is to be amended. The Norfolk Strategic Flood Alliance strategy was endorsed at Cabinet. The strategy is available in a draft document as part of the Cabinet agenda 20 September 2021. Breckland has launched a Mindful Towns and Villages project to coincide with World Mental Heath Awareness Day. The aim is to help communities become mental health champions. Helen is looking to recruit up to ten people in Carbrooke who are best placed to offer help.

Cllr Bowes (Norfolk County Council) noted that she had recently walked the Caudle Springs footpath and had requested a final cut to be made. The Trod is to be raked back. She noted there is Government funding for a road safety community fund through Norfolk County Council and she would like to apply for a 20mph speed limit from Caudle Springs to the school. This has been put into the Forward Plan. She was asked if the speed limit could extend throughout the older part of the village. Cllr Bowes said she will discuss this closer to the time. She noted additional Watch your speed signs have been installed. She has arranged for dog bins at the Caudle Springs footpath, location/s to be advised.

Cllr Sampher declared an interest in any matters relating to Blenheim Grange and the Community Hub.

Cllr Coppen declared an interest in any matters relating to the Millennium Green.

Cllr Coppen was appointed the Council's representative to the Village Hall.

#### 16 Tree on the Millennium Green

It was **RESOLVED** to buy a new copper beech (approx. 6ft) to replace the tree which is dead.
